**POLICY AGREEMENT FOR ALL PARENTS/GUARDIANS**

Student(s) enrollment at the School is subject to Parent/Guardian support of the standards of the School in its methods, objectives, and policies, including moral, academic, behavioral, dress, conduct, and disciplinary standards. Parent/Guardian also agrees to support, to the best of their ability, the School through attendance at parent meetings and participation in various School activities. To note:

- Parents/Guardians must honor the Home and School Association fundraising obligation of \$ 325.00 per family. Credit toward this obligation is earned by participating in fundraisers held throughout the year.
- Each family is required to volunteer at the School Carnival in the spring (2 volunteer shifts per family, 1 on Tue., Wed., or Thu. and 1 on Fri. or Sat.). Families who do not fulfill their carnival shift obligation will be subject to a fee of \$325 to be invoiced to their FACTS plan unless other arrangements are agreed upon with the HSA. Each family is **also** required to volunteer on the committee for one other major fundraiser (Auction Dinner or Golf Tournament).
- Parents/Guardians must enroll in the FACTS tuition plan and understand that any tuition, fees and expenses not paid when due will be invoiced to the FACTS plan.
- Additional unpaid fees and expenses will be processed through the FACTS plan, including, but not limited to:
  - Extension Care Fees
  - Field Trips, Graduation
  - Elementary Milk Program
  - Sports and Club Participation
  - School Registration Fee
  - Fundraising Obligation
- 8<sup>th</sup> grade tuition must be paid in full by May 1, 2025 unless other arrangements have been made with the administration.

**PAYMENT AND LATE FEES:** Parent/Guardian understands and agrees that a Late Charge of \$25.00 will be added for any delinquent payment that is 30 days past due, for every 30 days past due, up to a maximum of 90 days. As to any account more than 90 days in arrears, the School reserves the right to accelerate the total unpaid balance of tuition and fees under this Enrollment Contract. When accounts are in arrears, the account may be referred to the School’s collection agent and/or counsel for satisfaction. Parents/Guardians are encouraged to work with the Business Manager to arrange payment plans as soon as possible to avoid a larger balance due should an unforeseen issue arise with tuition payments.

**DEFAULT OF PAYMENT:** All accounts must be current before records and transcripts can be released or transferred to other schools. Student will not be allowed to continue to participate in school sports teams (practices and games) or other School activities unless tuition and fees are paid by stated deadlines (or until Parent/Guardian makes other written arrangements acceptable to the School).

**FUTURE REGISTRATION:** Any account with an unpaid balance for the academic year relating to this contract may not register for the following academic year until the outstanding tuition balance and accrued fees for the current academic year are paid.

**RETURNED CHECKS:** All returned checks will incur a fee of \$35.00 per returned check.

**SCHOOL WITHDRAWAL:** Determination of whether any tuition paid or upcoming tuition due for the academic year will be decided on a case-by-case basis and will be at the discretion of the School administration.

**FORCE MAJEURE:** The School’s duties and obligations under this Contract shall be suspended immediately without notice during all periods that the School is closed because of force majeure events including, but not limited to, any fire, act of God, hurricane, war, governmental action, act of terrorism, epidemic, pandemic, or any other event beyond the School’s control. If such an event occurs, the School’s duties and obligations in this Contract will be postponed until such time as the School, in its sole discretion, may safely reopen. In the event that the School cannot reopen due to an event under this clause, the School is under no obligation to refund any portion of the tuition paid.
